RESOLUTION 21-43

AUTHORIZING MODIFICATIONS TO THE AGREEMENT FOR SERVICES BETWEEN THE MADISON COUNTY MASS TRANSIT DISTRICT AND THE AGENCY FOR COMMUNITY TRANSIT, INC.

WHEREAS, the Madison County Mass Transit District (District) was created in December, 1980, by resolution of the Madison County Board pursuant to Section 3 of the Local Mass Transit District Act, approved July 21, 1959 as amended (70 ILCS 3610/1 et seq.) to foster an improved coordinated transportation system; and,

WHEREAS, the District has the responsibility to operate and maintain mass transit as a public service for the welfare of the residents of the District and the vitality of Madison County, Illinois; and,

WHEREAS, the District has maintained agreements with The Agency for Community Transit, Inc. (Agency) since 1986 with tremendous success and growth in its long-standing relationship with the Agency for Community Transit, Inc.; and,


WHEREAS, the District executed an Agreement most recently on May 28, 2020, with the Agency to provide management services, operate public transit service, provide paratransit service, maintain and develop the District's system of trails and bikeways, oversee the RideFinders program, and provide management services as directed by the District; and,

WHEREAS, the District and the Agency are both desirous of amending the current Agreement for paratransit services, public bus service, rideshare service, MCT Trails maintenance, and management services in Madison County, Illinois.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE MADISON COUNTY MASS TRANSIT DISTRICT THAT:

1. The Board authorizes and directs its Chairman, Ron Jedda, or its Vice Chairman, Kelly Schmidt, of the Madison County Mass Transit District to modify the agreement with the Agency for Community Transit, Inc., to provide management services, operate public transit service, provide paratransit service, oversee the RideFinders regional rideshare program, and to maintain and develop the District's system of bikeways and trails, as set forth in the attached Agreement for Services.



Agreement for Services

This Agreement entered into by and between the AGENCY FOR COMMUNITY TRANSIT, INC., Madison County, Illinois, a not-for-profit corporation (hereinafter referred to as the "AGENCY") and the MADISON COUNTY MASS TRANSIT DISTRICT, Madison County, Illinois (hereinafter referred to as the "DISTRICT"):

WITNESSETH THAT:

WHEREAS, in accordance with the Illinois Local Mass Transit District Act, 70 ILCS 3610, the DISTRICT is required to provide for the operation of mass transit as a public service for the residents of the District; and

WHEREAS, the geographic, demographic, and socio-economic characteristics of Madison County require the operation of an integrated network of fixed-route transit and paratransit services for the provision of efficient and effective mass transit system in Madison County; and

WHEREAS, the DISTRICT supported the formation of the AGENCY in 1984 and contracted with the AGENCY to provide a specialized paratransit service for the residents of Madison County; and,

WHEREAS, the AGENCY's responsibilities subsequently increased to provide public fixed-route transit, utilizing smaller buses than the regional operator, thereby increasing service to community neighborhoods, social service providers and shopping centers, and

WHEREAS, in 1998, the AGENCY assumed the full responsibility for providing all of the transit services for the DISTRICT, and,

WHEREAS, since 1986, under AGENCY's management of the DISTRICT, the DISTRICT's services have greatly expanded to include: a hub and spoke network of fixed-route public buses, the development and operation of the St. Louis Regional Rideshare Program known as RideFinders, and the development of an extensive system of interconnecting bikeways and trails that integrate with the District's transit system, and

WHEREAS, the DISTRICT and the AGENCY are desirous of maintaining the successful relationship that has benefitted the residents of the DISTRICT and improved the quality of life in the region, and

WHEREAS, the DISTRICT and the AGENCY entered into an Agreement for Services effective July 1, 2020 which the parties now desire to revise and modify as set forth herein.

NOW THEREFORE, in consideration of the premises and mutual covenants and undertakings set for hereinafter, the AGENCY and the DISTRICT agree as follows:

1. Term of Agreement

The term of this Agreement is fifteen (15) years, beginning July 1, 2020 through midnight, June 30, 2035. At the conclusion of the term of this Agreement it shall automatically renew, and shall remain in full force and effect according to the same terms and conditions as stated herein, for successive terms of five (5) years each, unless either party provides written notice to the other party of its intention to terminate this Agreement at the conclusion of its then current term; with the said written notice to be delivered to the other party no later than two (2) years prior to the ending date of the then current term of the Agreement.

2. Scope of Services

A. General Management, Administration, and Operation:

During the term hereof, the DISTRICT engages the AGENCY to provide General Management, Administrative, and Operational services as required and as described herein:

Any and all applicable responsibilities imposed upon the DISTRICT, as required by any federal, state, or local statute, regulation, rule, contractual obligation, grant requirement, and/or any other applicable legal obligation, shall be the compliance responsibility of the AGENCY. For example, as a Federal Transit Administration (FTA) Grantee, the DISTRICT is required to adopt FTA's Certifications and Assurances annually. It shall be the obligation of the AGENCY to ensure the DISTRICT's compliance with all applicable provisions of such.

Specific AGENCY administration and operational activities include, but are not limited to, the following: the provision of all required personnel to meet its administrative and operational obligations as described in this Agreement, personnel administration, payroll, accounting, compliance with the DISTRICT's policies: procurement, investment, etc., development of the DISTRICT's annual operating and capital budget for consideration and adoption by the DISTRICT Board, purchasing, development of operating policies and procedures; risk management, development of safety programs, operation, including utilities, insuring, maintenance, and repair of the Real Estate and Personal Property which are the subject of this Agreement, and any and all functions necessary to carry out the obligations as set forth in this Agreement.

B. Fixed-Route Transit:

During the term hereof, the DISTRICT engages the AGENCY to provide a professionally managed, public fixed-route accessible transit operation for the benefit of the residents of Madison County. Such operation shall include, but is not limited to, the following: planning and scheduling of routes, service evaluation; customer information; service supervision; operator training; risk management, fare analysis and enforcement, and overall operation of the transportation system. The level of service provided is generally described in APPENDIX A.

C. Paratransit:

During the term hereof, the DISTRICT engages the AGENCY to provide a professionally managed, full-service, public paratransit operation, currently known as the Runabout, for the benefit of those who are eligible who use the service. Such operation shall include, but is not limited to, the following: planning and scheduling of routes, service evaluation; registration of eligible applicants as defined by the Americans with Disabilities Act (ADA) and additional residents of Madison County as defined by the District, customer information; service

supervision; operator training; risk management, fare analysis and enforcement, and overall operation of the Runabout paratransit transportation system.
The level of service provided is generally described in APPENDIX B.

D. Maintenance:

During the term hereof, the DISTRICT engages the AGENCY to provide a professionally managed, full-service, maintenance program to ensure the safety of the DISTRICT's transit operation; and preserve the public investment in the DISTRICT's fleet and facilities. The level of maintenance service provided is generally set forth in the document Maintenance Guidelines for the Madison County Mass Transit District, as drafted by the Agency. The AGENCY agrees to keep the document current, and in compliance with, federal, state, and local regulations and/or requirements.

E. Rideshare:

During the term hereof, the DISTRICT engages the AGENCY to provide the administration and management of the St. Louis Regional Rideshare Program, currently known as RideFinders, as more fully described and set out in APPENDIX C.

F. Real Property

During the term hereof, the DISTRICT, as provided under 70 ILCS 3610/5(f)(14), engages the AGENCY to provide for the administration, planning, management, operation, and maintenance of District's Real Property, including its bikeways, trails, and rail corridors, except as the parties may otherwise separately agree.

G. Local Transportation Projects & Programs

During the term hereof, the DISTRICT engages the AGENCY to sponsor and support local governments and not for profit organizations in planning, implementing, administering, and operating local transit and transportation programs for the benefit of residents of communities within Madison County, Illinois.

3. Status of Parties

It is acknowledged and understood by and between the parties that the DISTRICT is a unit of local government in the State of Illinois, as defined in 70 ILCS 3610, Local Mass Transit District Act, which has contracted for a certain portion of its services to be rendered by the AGENCY which is a 501(c)(3) not-for-profit corporation. The AGENCY shall be fully responsible for the internal performance of its duties pursuant to this contract. At all times, the employees of the AGENCY shall be supervised by, and are under the direct control of, the AGENCY. The AGENCY shall be solely responsible for the hiring, termination of its employees, workers compensation, unemployment benefits, labor Agreements, personnel policies, payment of salaries and all other benefits of the employees. It is agreed and understood that nothing in this Agreement will preclude the AGENCY from engaging in other not-for-profit activities and undertakings consistent with its Articles of Incorporation, Bylaws, and applicable law so long as the AGENCY fulfills its obligations to the DISTRICT under the provisions of this Agreement.

4. The AGENCY to Carry Insurance

The AGENCY shall procure and maintain in force during the term of this Agreement, and any

extension thereof, to include, but not limited to: general liability, automotive liability, excess liability, storage tank liability, cyber liability, public officials liability, employee benefits liability, crime, property including flood, boiler and machinery, insurance, adequate, in the opinion of the DISTRICT, to protect against any and all reasonable liability for damage against claims through public use of, or arising out of, accidents/incidents occurring pursuant to this Agreement. The DISTRICT shall be carried as an additional and/or named insured in the AGENCY's insurance policies and will be named as a loss payee with respect to DISTRICT Real Property or Personal Property (as defined herein). The DISTRICT shall have the right to require the AGENCY to change the extent of coverage and policy limits of said insurance that covers solely the DISTRICT, whenever the DISTRICT deems it necessary to do so. The AGENCY shall have the sole authority to determine the extent and amount of insurance that covers solely the AGENCY. The DISTRICT will be responsible for all insurance premiums and deductibles with respect to any and all insurance coverages which are required under this Agreement.

5. The AGENCY's Right to Subcontract

The parties acknowledge, understand, and agree that in the performance of its duties and obligations pursuant to this Agreement, it may be necessary or desirous on the part of the AGENCY to subcontract its duties and obligations pursuant to this Agreement. However, such subcontracting shall not remove in whole or in part the AGENCY from any duty, obligation, right or liability pursuant to the terms of this Agreement unless otherwise specifically agreed by the parties in writing. The expenses associated with such subcontracting shall be payable by the DISTRICT.

6. Audit and Inspection of Records

The AGENCY shall maintain accounting and payroll records and other evidence pertaining to authorized costs incurred during the term and any extensions of this Agreement. All invoices shall be taken from the books of account kept by the AGENCY. The AGENCY shall have available copies of payroll distributions, receipted bills and other reasonable documents required by the DISTRICT. The AGENCY shall permit the authorized representatives of the DISTRICT to inspect and audit all data and records of the AGENCY relating to the AGENCY's performance under this contract. This data shall be retained by the AGENCY as necessary to meet all applicable grant, tax, auditing, and record retention requirements of both parties and will be made available for inspection by the DISTRICT or its authorized representatives at all reasonable times at the office of the AGENCY. Copies of such records and data shall be furnished by the AGENCY upon request.

7. Compliance with Other Agreements

The AGENCY, notwithstanding any other provision of this Agreement, shall not perform any act, enter into any subcontract or otherwise do anything which would cause the DISTRICT to be in violation of any Agreement the DISTRICT has with any entity or cause the DISTRICT to be in violation of any local, state, or federal rule, regulation, or statute.

8. Provision and Use of Personal Property

The DISTRICT owns motor vehicles, mechanical equipment, office furnishings, and office

equipment including information technology and communication systems, computer systems and equipment (hardware and software) [collectively referred to in this Agreement and this paragraph as the "Personal Property"] which the DISTRICT will make available to the AGENCY for its exclusive use in providing the services by the AGENCY to the DISTRICT under the provisions of this Agreement in accordance with the following terms:

A. The Personal Property which is the subject matter of this paragraph is generally described in the attached Exhibit "A" and will include additional items as may be acquired by the DISTRICT from time to time during the term of this Agreement, it being understood that additional and replacement vehicles and other items of Personal Property will necessarily be acquired and disposed of by DISTRICT during the term of this Agreement which will be done in consultation with the AGENCY throughout the term of the Agreement.

B. The Personal Property is to be used by AGENCY for the services provided by AGENCY to the DISTRICT and for the purposes of the DISTRICT, provided that the Personal Property may be used by the AGENCY in connection with other activities of AGENCY which are consistent with the purposes of the DISTRICT and the AGENCY.

C. During the term of this Agreement, the DISTRICT shall be responsible for any and all State license fees, City license fees, and all taxes on the vehicles which are part of the Personal Property.

D. The AGENCY shall maintain in continuous force and effect on each vehicle which is part of the Personal Property liability insurance; comprehensive fire and theft insurance; and collision and upset insurance as a reimbursable expense (including any deductible amounts). Such insurance shall be in amounts meeting all statutory requirements. The parties may obtain such insurance jointly, subject to approval of the DISTRICT. All policies of insurance shall include both DISTRICT and AGENCY as insureds and DISTRICT will be named as loss payee on Personal Property titled in DISTRICT'S name. All vehicle insurance policies shall not be subject to cancellation without at least ten (10) days prior written notice to DISTRICT. AGENCY shall provide DISTRICT with evidence of the existence of all required insurance upon delivery of the vehicles to AGENCY and at such times during the term of this Agreement that DISTRICT may reasonably require. DISTRICT and AGENCY agree that AGENCY shall use the proceeds of any insurance received from claims on the vehicles as defined in Exhibit A, to repair or to replace damaged vehicles. AGENCY shall comply with all terms and conditions of the insurance policies covering the vehicles.

E. As the Personal Property, including vehicles which are part of the Personal Property, is intended to provide service for the purpose of DISTRICT there will be no lease payment during the term of these lease agreement.

F. This Agreement does not provide with any option to purchase any of the vehicles which are part of the Personal Property.

G. At the end of the term of this Agreement AGENCY shall deliver the vehicles to DISTRICT at a location as reasonably specified by DISTRICT and AGENCY shall return each

vehicle and the other items comprising the Personal Property to DISTRICT at the end of the term of the Agreement (or ~~upon~~ earlier termination) in good and efficient working order, repair, and condition, ordinary wear and tear excepted.

H. The AGENCY will dispose of obsolete, damaged, or uneconomical vehicles or other items of Personal Property in accordance with 70 ILCS 3610/5(f)(4) or other applicable law or regulation with the approval and direction of the DISTRICT.

I. AGENCY shall provide all maintenance and servicing of the Personal Property, including each vehicle, in good working order, repair and condition, except to the extent that the obsolescence, condition, or damage to a vehicle or other Personal Property makes it impractical or uneconomical to do so.

J. AGENCY shall allow only duly authorized and licensed drivers to operate any of the vehicles. AGENCY shall use all vehicles in compliance with all State, Federal, and Municipal laws and ordinances. Vehicles shall not be used for any illegal purposes. AGENCY shall promptly pay and discharge all fines imposed or arising out of the use of the vehicle. AGENCY shall comply with any standards and in accordance with any Federal, State, or local requirements as set out by grant agreements of the DISTRICT.

K. AGENCY shall at all reasonable times upon request of DISTRICT notify DISTRICT as to the location of any of the vehicles which are part of the Personal Property.

L. If any of the vehicles are lost, stolen, destroyed, or become a constructive total loss, AGENCY shall promptly notify DISTRICT and hold any salvage for DISTRICT.

M. DISTRICT will not under any circumstances be obligated to furnish AGENCY with any replacement vehicle, to provide any other provision for transportation, or to assume any obligation for any other loss of use of vehicle when any vehicle may be out of service for any reason.

N. DISTRICT shall not be liable for any delay in delivering vehicles which are part of the Personal Property due to fire or other casualty, labor difficulty, governmental restriction, or any other cause beyond the reasonable control of DISTRICT. In no event shall DISTRICT be liable for any loss of profits, consequential damages, inconvenience, rental of any replacement vehicle, or other damages due to any theft, damage, loss, defect, or failure of any vehicle or the time consumed in recovering, repairing, servicing, or replacing any vehicle, and there shall be no abatement or apportionment of the rental payments during any such time.

O. AGENCY shall not assign this Lease or any interest therein without the prior written consent of DISTRICT.

P. Other than any warranty which may be provided by the manufacturers or providers of the Personal Property, **THERE ARE NO OTHER WARRANTIES EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY WARRANTY AS TO**

MERCHANTABILITY OR ANY WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE

made by the DISTRICT to the AGENCY. No dispute between the AGENCY and the manufacturer about warranty shall affect the obligation of AGENCY under this Agreement, nor shall any defects in the Personal Property affect AGENCY's obligations under this Agreement. The AGENCY will at all times during the term of this Agreement have the right to exercise any rights of the DISTRICT with regard to any warranty or any other claim against any manufacturer or provider of any item which is part of the Personal Property due to defect or failure to perform.

9. Provision and Use of Real Estate

The DISTRICT will make available for AGENCY'S use and possession during the term of this Agreement its Real Estate to enable AGENCY to provide the services to be furnished to DISTRICT and the DISTRICT will reimburse the AGENCY for all costs incurred by AGENCY with respect to its use and possession of such Real Estate. For purposes of this Agreement and this paragraph, Real Estate will include land, buildings, facilities, and structures owned, leased, or held/used/occupied by DISTRICT under an intergovernmental agreement or other legal arrangement, or which DISTRICT otherwise controls or occupies, including, but not limited to, the premises commonly known as One Transit Way, Pontoon Beach, Illinois which currently houses the administrative offices and garages which are utilized by the AGENCY in providing the services to DISTRICT under the provisions of this Agreement and which premises are more particularly described in the attached Exhibit B. Such use and occupancy are provided on the following terms:

A. Subject to the reasonable use of the Board Room, Lobby, and public areas of the premises commonly known as One Transit Way, Pontoon Beach, Illinois by the DISTRICT for its Board of Trustee meetings, public meetings and hearings, and similar activities, unless otherwise mutually agreed by the parties, the AGENCY will have the exclusive use, occupancy, and control of the Real Estate throughout the term of this Agreement and will be responsible for its operation, repair, and maintenance without the payment of rent, the consideration for such use and occupancy being the provision of the services by the AGENCY to the DISTRICT under the terms of this Agreement.

B. The AGENCY will be responsible to procure, in addition to the insurance coverages required by Section 4 of this Agreement, public liability and fire and casualty insurance on the Real Estate which will insure the Real Estate against liability claims with respect to the Real Estate as a reimbursable expense (including any deductible) and name the DISTRICT and the AGENCY as insureds and name the DISTRICT as loss payee as the holder of legal title to the Real Estate. The AGENCY will provide the DISTRICT with evidence of such insurance coverage which will be procured through companies authorized to do business in the State of Illinois or by other means, such as self-insurance or insurance pools, approved by the DISTRICT.

C. Throughout the term of this Agreement, the AGENCY will not commit or allow to be committed any waste on the Real Estate, create or allow any nuisance to exist on the Real Estate, or use or allow the Real Estate to be used for any unlawful purpose.

D. The AGENCY will be responsible throughout the term of this Agreement to arrange and pay for utility services to the Real Estate as a reimbursable expense.

E. At the conclusion or termination of this Agreement, the AGENCY will surrender the Real Estate to the DISTRICT in generally the same condition as when received subject to reasonable use, wear and tear, and damage by fire, windstorm, flood, or other casualty or Act of God.

F. The DISTRICT will have the right of reasonable entry into and on the Real Estate throughout the term of this Agreement for purposes of inspection, however, such entry shall be upon reasonable notice to the AGENCY and shall not disrupt AGENCY'S operations.

G. The AGENCY will have the right and authority during the term of this Agreement to lease to other parties a portion of the Real Estate with the prior written approval of the DISTRICT, which approval shall not be unreasonably withheld.

H. It is understood and acknowledged that the composition of the DISTRICT'S Real Estate holdings will change over the course of this Agreement and that parcels of real estate will be added to the DISTRICT'S Real Estate and parcels currently included in the DISTRICT'S Real Estate will be removed by sale, donation, transfer, or the expiration of leaseholds or intergovernmental agreements or other arrangements pursuant to which parcels are held by the DISTRICT in its Real Estate. It is agreed that such additions to DISTRICT'S Real Estate will be subject to this Agreement unless otherwise mutually agreed by the parties, and that parcels which are removed from Real Estate will no longer be subject to this Agreement unless otherwise mutually agreed by the parcels.

10. Compensation and Reimbursement

A. The DISTRICT agrees to reimburse the AGENCY for all of its costs incurred for providing the services to DISTRICT under this Agreement, including, but not limited to all of its costs incurred for providing the services as described in sections 2 through 9 inclusive in accordance with the stipulations of Appendices A through C as well as any additional or different services which may be provided by the AGENCY to DISTRICT, prospectively, during the term of this Agreement.

B. In addition to the reimbursement of its costs as set out in A., above, the DISTRICT also agrees to pay the AGENCY the sum of \$400,000.00 per year as a fixed fee to cover indirect costs and separate expenses of the AGENCY for its operations. Such annual payment shall be made on or before the end of the DISTRICT'S fiscal year. This amount shall be updated annually during the term of the Agreement to reflect a percentage increase (if any) in the CPI-W from the average for the third quarter of the current fiscal year to the average for the third quarter of the previous year.

C. The DISTRICT agrees, that to the extent required by applicable law, it will annually appropriate sufficient moneys to fund the payments called for under this Section 10 of the Agreement.

11. Late Payment/Early Termination Fee

A. The DISTRICT agrees to pay to the AGENCY a late payment charge as to any amounts required to be paid to the AGENCY by the DISTRICT under the provisions of this Agreement, but

which are not timely paid, including, but not limited to, the payments described and provided for in Appendices A, B, and C hereof, which late payment charge will be equal to the unpaid balance due times the US Prime Interest Rate for each month payment is late. For purposes of this paragraph a payment will be untimely if paid more than ten (10) days after the prescribed due date for payment by the DISTRICT to the AGENCY. Should the DISTRICT dispute any part of an amount the AGENCY asserts to be due, the DISTRICT will pay any undisputed portion the amount claimed due by the AGENCY and will pay, and not withhold, any undisputed amount.

B. The AGENCY and DISTRICT acknowledge the complicated, lengthy, and costly process needed to establish, administer, operate, and staff an organization to effectively perform the various services provided by the DISTRICT. Additionally, the DISTRICT acknowledges that the AGENCY in its efforts to meet the requirements of this Agreement in the most cost-effective manner, will enter into long-term contracts for labor, services and materials and any unplanned change in the Agreement would result in significant potential financial liabilities for the AGENCY. Therefore, AGENCY and DISTRICT agree that any non-mutual agreed upon termination of this Agreement by the DISTRICT outside of the agreed terms set forth in paragraph 1 will require full payment by the District to the AGENCY of an amount equal to twice the amount of the most recent full year's fee together with the actual reasonable expenses incurred by the AGENCY in winding down its relationship with the DISTRICT with such payments to be made in monthly installments in the two (2) years following the date of termination.

12. Indemnification

The AGENCY agrees to indemnify and to hold harmless the DISTRICT and its officers, agents, and employees against any loss, claim or suit hereinafter made or brought against DISTRICT or its officers, agents, or employees arising directly from the act or omission to act of the AGENCY, its officers, agents, or employees in the provision of services hereunder. The DISTRICT agrees to indemnify and to hold harmless the AGENCY and its officers, agents, or employees against any loss, claim or suit hereinafter made or brought against the AGENCY or its officers, agents, or employees arising directly from the act or omission to act of the DISTRICT, its officers, agents, or employees under this Agreement.

13. Default

Should either party default in carrying out the duties, terms, and/or provisions of this Agreement, the non-defaulting party shall provide written notice in the manner provided below to the party asserted to be in default of the claimed default. If the asserted default is in the payment of money, the defaulting party shall have ten (10) from the date the written notice is received to cure the payment default, or, in the case that the default is with respect to any other requirement or performance under this Agreement, the party asserted to be in default shall have thirty (30) days from the date that the notice of default is received to cure the default unless the default is of a type or nature that cannot be cured within such thirty (30) day period, the defaulting party shall reasonably commence the cure of the default within the said thirty (30) day period and accomplish such cure within a reasonable period of time given the nature of the asserted default. In the event that the party claimed to be in default contests the assertion that the party is in default or if the defaulting party fails to cure the asserted default within the time provided herein, the non-defaulting party may proceed to the dispute resolution procedures provided for in this agreement.

14. Dispute Resolution

Disputes between the DISTRICT and the AGENCY relating to the terms of this contract shall be arbitrated in accordance with the laws of the State of Illinois, provided, however, that prior to a party initiating arbitration, the parties shall confer and if unable to resolve the dispute between themselves, they will engage in mediation as a prerequisite to arbitration. The parties may mutually agree upon an arbitrator or, if they cannot agree, the parties shall each select an arbitrator; the two (2) arbitrators shall then select another arbitrator. The three (3) arbitrators shall hear and determine the dispute with dispatch. Their decision shall be binding on the parties hereto. The parties agree to divide mediation and arbitration costs equally between them. Due to the significant costs and expenses incurred by the AGENCY in providing the services called for in this Agreement and due to the reliance upon the AGENCY for reimbursement from the DISTRICT, it is agreed by both parties that the DISTRICT shall have a duty and obligation to continue to make the payments called for by the terms of this Agreement to the AGENCY when due until otherwise directed by the decision of an arbitrator. In the event that the DISTRICT unilaterally withholds payment from the AGENCY prior to the receipt of an arbitrator's decision to do so, the AGENCY shall be entitled to seek appropriate injunctive or other equitable relief or other remedy in a court of law to require the DISTRICT to comply with the obligation to reimburse and pay the AGENCY.

15. AGENCY Property

In the event that the AGENCY procures Real Property or Personal Property (as those terms are defined elsewhere in this Agreement) utilizing funds which are not provided by the DISTRICT to the AGENCY as a direct cost reimbursement (for example, funds derived from the annual fee paid by DISTRICT in addition to the reimbursements provided for herein or from grants obtained by the AGENCY independent of the DISTRICT), such property shall constitute the property of AGENCY upon termination of this Agreement for any reason and the AGENCY shall have the right to receive and retain such property upon termination of this Agreement.

16. Other Terms and Provisions

- A. If any provision of this contract is determined to be invalid, or contrary to or not in compliance with any federal or state statute, rule, or regulation applicable to the parties, the remaining provisions of this Agreement will remain in full force and effect.
- B. The terms and conditions of this Agreement shall remain in full force and effect during its term and any extension thereof unless otherwise specifically agreed by the parties in writing.
- C. The parties acknowledge and understand that it may be beneficial to both parties to amend the Agreement from time to time and that such amendments shall be made in writing and no amendment to this Agreement will be effective unless it is encompassed in a writing signed by all parties to the Agreement.
- D. This Agreement shall be governed by and construed under the law of the State of Illinois excluding only choice of law principles.

- E. Time is of the essence of this Agreement.
- F. A waiver of any performance under this Agreement on one or more occasions by a party shall not constitute or be deemed a continuing waiver of that same or any other performance under this Agreement.
- G. This Agreement and its provisions shall be binding on the parties, their legal representatives, successors, and assigns.
- H. This Agreement shall not be assigned by either of the parties without the consent of the other party which shall not be unreasonably withheld.
- I. This Agreement shall be governed by the law of the State of Illinois excluding, however, choice of law principles.
- J. This Agreement constitutes the complete agreement of the parties and all prior negotiations are merged herein.
- K. The provisions of this Agreement which require continuing performance shall not be merged upon termination of the Agreement and shall survive its termination.
- L. This Agreement may be executed in any number of counterparts each of which shall be deemed to constitute one and the same original document. Fully executed facsimile copies shall be deemed true copies, provided, however, that the parties will execute and exchange original counterparts as soon as is practicable following execution.
- M. Should the time period by which any act or performance under this Agreement must occur or be exercised expire on a Saturday, Sunday, or legal or bank holiday, then the time period for such performance shall automatically be extended to the close of business on the next business day.
- N. It is expressly agreed by the parties that all provisions of this Agreement are solely for the benefit of the parties and are not for or to be construed to be for the benefit of any third party or to create any right in any third party.
- O. The parties agree at all times to exercise good faith in carrying out the terms of this Agreement and to attempt to resolve any dispute by consultation prior to the initiation of dispute resolution proceedings.
- P. Any notice which is required to be given under this Agreement must be in writing and supplied to the other party by personal delivery, United States Mails, express or overnight delivery, electronic mail or facsimile/telecopier. If given by personal delivery or express or overnight delivery service, notice is effective on delivery. If given by United States mail, notice is effective upon verification of receipt by certified or registered mail. If by electronic mail or facsimile/telecopier, notice is effective upon confirmation of receipt by the other party. Notice shall be given by each party to the other party at the address furnished by that party at the time this Agreement is executed. Such address may be changed at any time upon written notice to the other party.

Q. Neither party shall be responsible for delay or failure of performance of any of its obligations under this Agreement caused in whole or in part by: Acts of God, wars, riots, fires, explosions, breakdowns or accidents; strikes, lockouts or other labor difficulties; lack or shortages of labor, materials, utilities, energy sources, compliance with governmental rules, regulations or other governmental requirements; pandemic or public health emergency or disaster declaration in the area comprising the DISTRICT or near thereto; or any other like causes or unlike causes beyond the control of the party whose performance is affected thereby. The foregoing shall be in addition to and not in limitation of any excuses for nonperformance available to the party whose performance is affected under any applicable law. The party whose performance is so affected shall make all reasonable efforts to remove such disability as soon as possible, except for labor disputes which shall be solely within such party's discretion.



APPENDIX A FIXED ROUTE SERVICE

A. As provided in Section 2.B of the Agreement, the AGENCY will provide fixed-route public bus service for the DISTRICT, at a level and area of operation, as generally operated on September 1, 2020, which service will constitute the benchmark minimum for purposes of this Appendix.

B. No service, except special event service as directed by the DISTRICT, will be provided on the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas.

C. The DISTRICT agrees to reimburse the AGENCY all of its operating cost incurred to provide the agreed fixed route services annually along with the associated costs as set out in Section 2.D. of the Agreement, it being understood by the DISTRICT and the AGENCY that the amount of fixed-route service will be determined annually by the mutual agreement of the parties. In the event the level of service needs to be modified in any subsequent year, it shall be agreed upon before June 30th of the fiscal year for the next fiscal year. At each fixed-route service change, the DISTRICT may also modify the level of service and/or amount of payment thereof, thereby modifying the annual estimated cost of the service and associated maintenance cost, provided that the level of payment shall not fall below an amount based on the benchmark minimum level unless a reduction is mutually agreed upon by the parties.

D. The AGENCY shall initially fund the cost of providing the service as described herein. On or before the 20th day of each calendar month, the AGENCY shall provide the DISTRICT with an invoice for the direct cost for the service provided for the prior month. The DISTRICT shall pay the AGENCY'S invoice on or before the last day of the month the invoice is issued.

E. The DISTRICT shall have the sole authority to set, modify, suspend, or enforce the fares charged for any fixed-route service provided by the AGENCY. The AGENCY will charge, collect, and retain the fares for the fixed-route service provided.

APPENDIX B PARATRANSIT

- A. The AGENCY will provide paratransit (origin to destination) Americans with Disabilities Act (ADA) compliant transportation for registered ADA eligible riders, during the times and days the Fixed Route public bus service operates. The AGENCY will also provide paratransit service to the registered elderly residents of Madison County, provided such service will not encumber the AGENCY's ADA responsibilities. No service, except mandated (ADA) service will be provided on the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas. The paratransit service level being provided by the AGENCY at September 1, 2020 shall constitute the benchmark minimum for purposes of this Appendix.
- B. The Agency will limit the paratransit service for eligible individuals to trips that originate and terminate within Madison County with the exception of medical trips or ADA mandated trips that may originate or terminate outside the County.
- C. To avoid the unnecessary duplication of service, the AGENCY shall refer individuals who are able to utilize the public fixed-route service, but are requesting paratransit service, to existing fixed-route service whenever feasible.
- D. The DISTRICT agrees to reimburse the AGENCY all of its operating cost incurred to provide the above paratransit service, as described in Section 2(C) of the Agreement, and the cost of the associated services as set forth in Section 2(D) of this Agreement, , it being understood by the DISTRICT and the AGENCY that the amount of paratransit service will be determined annually by the mutual agreement of the parties. In the event the level of service needs to be modified in any subsequent year, it shall be agreed upon before June 30th of the fiscal year for the next fiscal year. At each paratransit service change, the DISTRICT may also modify the level of service and/or amount of payment thereof, thereby modifying the annual estimated cost of the service and associated maintenance, provided that the level of payment shall not fall below an amount based on the benchmark minimum level unless a reduction is mutually agreed upon by the parties.
- E. The AGENCY shall initially fund the service as described herein. On or before the 20th day of each calendar month, the AGENCY shall provide the DISTRICT with an invoice for the cost for the service provided for the prior month. The DISTRICT shall pay the AGENCY's invoice on or before the last day of the same month the invoice is issued.
- F. The DISTRICT shall have the sole authority to set, modify, suspend, or enforce the fares charged for any paratransit service provided by the AGENCY. The AGENCY will charge, collect, and retain the fares for the paratransit service provided.
- G. The AGENCY shall have permissive authorization by the DISTRICT to negotiate special Agency Transportation Fares in excess of the standard fares, with other entities where paratransit service transportation is required for the entity and where the entity receives funding to provide transportation for the entity's programs.

* Currently, the DISTRICT includes the townships of Alton, Chouteau, Collinsville, Edwardsville, Ft. Russell, Foster, Godfrey, Granite City, Jarvis, Moro, Nameoki, St. Jacob, Venice, and Wood River.

APPENDIX C RIDESHARE

- A. During the term of this Agreement, the AGENCY will provide the administration and management of the St. Louis Regional Rideshare Program, currently known as RideFinders.
- B. RideFinders is a marketing and outreach program designed to encourage ridesharing thereby reducing pollution caused by single occupant vehicles. RideFinders' services are available to all employers in the Illinois Counties of Madison, Monroe and St. Clair, the Missouri Counties of Franklin, Jefferson, St. Charles and St. Louis, and the City of St. Louis.
- C. The RideFinders' mission is to: *"Promote ridesharing through employer and employee education incentives and technology; to promote carpooling, vanpooling, public transit and other innovative modes of travel which help to reduce the congestion and pollution created by commuters driving alone."*
- D. The DISTRICT maintains funding Agreements with the Missouri Department of Transportation (MoDOT) and the Illinois Department of Transportation (IDOT) to fully fund this regional program. In the event that its funding may cease, in whole or in part, the DISTRICT shall provide the AGENCY with written notification to modify or suspend the RideFinders activities on behalf of the DISTRICT. In such case, the AGENCY will have 90 days to modify or cease such operation, and the DISTRICT shall reimburse the AGENCY for its cost associated with the termination of the program. Unless otherwise agreed between the parties, the DISTRICT will reimburse the AGENCY for all of its incurred costs associated with this program for the term of this Agreement. The AGENCY shall initially fund the service as described herein. On or before the 20th day of each calendar month, the AGENCY shall provide the DISTRICT with an invoice for the cost for the service provided for the prior month. The DISTRICT shall pay the AGENCY's invoice on or before the last day of the same month the invoice is issued.
- E. From time to time, the DISTRICT may have supplemental Agreements with the AGENCY to implement ridesharing services for the region based upon the timing of funding Agreements with MoDOT or IDOT. In the case of conflicting language between this Agreement and the supplemental Agreements, this Agreement for Services shall govern.
- F. The AGENCY shall be responsible for the program management, administrative staffing, match list processing and database management, regional coordination, project performance monitoring and reporting functions.
- G. The AGENCY shall be responsible to provide the management, staffing, coordination, and maintenance to implement and continue the RideFinders Vanpool program. The DISTRICT, through the use of federal and state grants, may purchase the vehicles to be utilized within the Vanpool program. All such vehicles purchased by DISTRICT will be titled to the DISTRICT and the AGENCY will not have any direct interest in the ownership of such vehicles.
- H. The DISTRICT will continue to provide oversight of the RideFinders Program to ensure its effective implementation.
